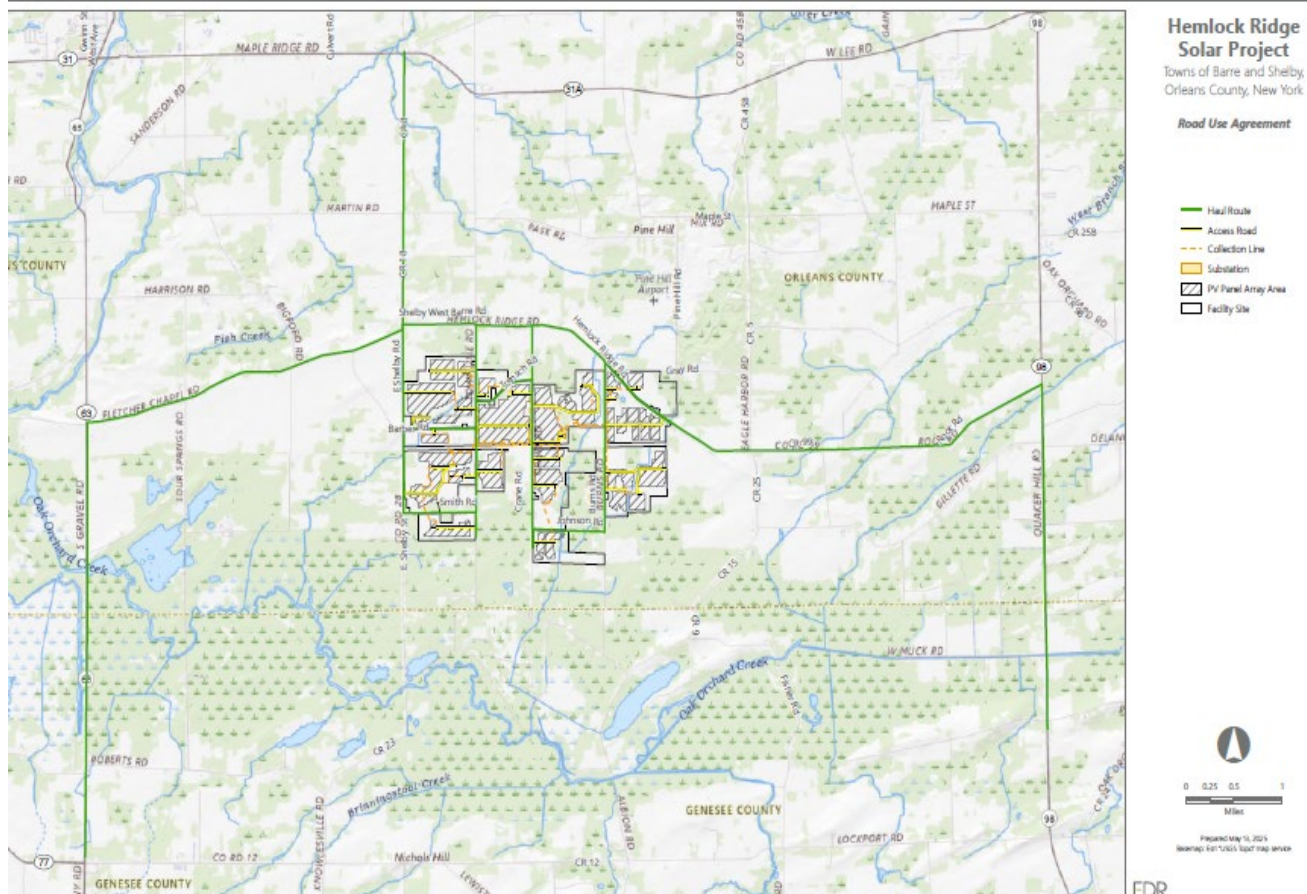


This notice announces that, on or about March 16, 2026, Hemlock Ridge Solar LLC (Hemlock Ridge or Permit Holder) will begin tree felling activities (Phase I) to support the commencement of construction of the 200-megawatt (MW) Solar Electric Generating Facility located in the Towns of Barre and Shelby, Orleans County, NY (the Facility).

Pursuant to Article VIII of the New York State Public Service Law (the Article VIII process), this notice is being provided in accordance with *Section 5, Subsection 5.2(a)* of the Facility's Siting Permit for a Major Renewable Energy Facility, which was issued by the Office of Renewable Energy Siting and Electric Transmission (ORES) on September 22, 2022. BRIEF DESCRIPTION OF THE PROJECT

Hemlock Ridge will construct the Facility in the Towns of Barre and Shelby, Orleans County. When completed, the Facility will have a total generating capacity of up to 200-megawatts (MW). In addition to photovoltaic (PV) solar arrays, the Project will include: racking support structures; inverters; medium voltage transformers; an on-site substation featuring a high voltage transformer; access roads; security fencing and gates; communication cabling; electrical collector cabling consisting of direct current (DC) electrical cables connecting solar panels to inverters and buried and overhead alternating current (AC) electrical cables connecting the inverters to the substation; and temporary construction laydown areas. The substation and a proposed point of interconnection (POI) switchyard located within the Facility Site will interconnect the Facility via overhead transmission lines running to the existing National Grid 115 kV Lockport to Mortimer electric circuit.

CONSTRUCTION SCHEDULE

Phase I of construction consisting of tree felling is scheduled to begin on or about March 16, 2026. Thereafter, construction will proceed according to the below phases and approximate schedule:

- Site Preparation and Civil Construction in or around July 2026; and
- Photovoltaic Installation in or around August 2026.

All construction activities shall be limited to 7:00 a.m. to 8:00 p.m. Monday through Saturday and 8 a.m. to 8:00 p.m. on Sunday and on national holidays.
